Recruiting, Training and Retaining Talent in the Real Estate Development Industry

Real estate firms of all kinds rely on their employees to grow and thrive. The importance of talent is even more pronounced in the commercial real estate development industry, where employees' abilities and personal judgment make the difference between successful projects, those that fail to meet investor expectations and those that never make it off the drawing board. A commercial real estate firm's ability to recruit, train and retain talent is therefore a critical source of competitive advantage.



SHAPE POLICIES

NAIOP is dedicated to the advancement of the commercial real estate business environment through local lobbying efforts.



NAIOP Calgary's Government Affairs Committee, composed of leaders in the city's commercial real estate sector, works to advance industry conditions through active policy engagement and advocacy. The Committee monitors and responds to municipal policy and bylaw issues, collaborating closely with groups such as BOMA and BILD Calgary Region to promote positive change. NAIOP has contributed to key initiatives, including revisions to the Centre City Levy and discussions on property tax allocation between business and residential properties. Since 2021, Committee members have met regularly with Calgary's Mayor to address issues shaping downtown and the broader commercial real estate landscape.

Government Affairs Committee - Key Advocacy Highlights:

NAIOP Calgary, alongside BOMA, CDA, and CCA, led advocacy on the Green Line alignment through the Beltline and Downtown. Following the Government of Alberta's funding withdrawal and review in 2024, NAIOP's efforts helped secure Council approval of the revised alignment—from Shepard Station to Grand Central and elevated along 10th Avenue and 2nd Street SW—resulting in funding being restored. NAIOP also initiated stakeholder engagement and continues to work with the City's project team on the ongoing alignment review.

Non-Residential Property Tax Shift

In partnership with BOMA, CDA, and The Chamber, NAIOP helped complete the final year of the City's 1% annual tax shift from non-residential to residential taxpayers. The committee continues to advocate for a balanced 60/40 residential-to-non-residential tax split (currently 53/47), highlighting how the disproportionate

burden on commercial taxpayers impacts Calgary's business competitiveness and small business retention.

City Planning Framework Overhaul

NAIOP has provided extensive input on the City's new Calgary Plan, Zoning Bylaw, and Street Manual—three key documents guiding growth over the next decade. Through ongoing collaboration with City administration, NAIOP's recommendations have contributed to multiple extensions, ensuring more thorough consultation and alignment with industry needs before adoption.

Industrial Growth Strategy

NAIOP has been a leading voice on the City's Industrial Strategy Working Group, addressing barriers that have driven new industrial development to Rocky View County. The group's work has led to a forthcoming incentive plan—targeted for inclusion in the 2026 budget—to support greenfield industrial projects through development charge and tax relief, positioning Calgary to better compete for future industrial investment.
